- a) By completing this Application Form for Interbank GIRO (“**GIRO**”), you are authorizing Vegetarian Society (Singapore) (“**VSS**”) to request your bank to automatically debit your bank account as indicated overleaf (“**your Account**”) to make a contribution of the amount as indicated overleaf to VSS and are instructing your bank to carry out such debits as per VSS’s request.
- b) The scheduled deduction date is on the 5<sup>th</sup> of each month. Please ensure that sufficient funds are maintained in your Account. The scheduled deduction date is fixed with the bank and cannot be changed. The only exception is when the scheduled deduction date falls on a Sunday or Public Holiday; deduction will take place on the next working day.
- c) In normal circumstances, it would take 4 to 6 weeks for your bank to approve your application herein. On receipt of bank’s approval, VSS will inform the customer via email or in writing of the date when the first deduction is to take effect.
